The Freeholder Director was told that both pending bills eliminate the regional coordination requirement.

Mayor Mahon advised that there should be a specific committee to address housing to insure that the issues are properly addressed. He recommended that the committee's membership include the three mayors of Oceanport, Tinton Falls and Eatontown and Department of Community Affairs (DCA) Assistant Commissioner Chuck Richman.

DCA Assistant Commissioner Chuck Richman noted that he agreed with the Deputy Attorney General's counsel

Assistant Commissioner Richman reiterated the advice of counsel and recommended

Mayor Tarantolo inquired about the growth share requirement. He noted that Eatontown is one of 31 municipalities involved in the League of Municipalities' litigation against COAH's third round rules. He also stated that each of the three host municipalities has some degree of an affordable housing plan and Fort Monmouth was to be treated independently. He also noted that the FMERPA Social Services Committee addressed housing issues.

In response to concerns as to whether establishing a housing advisory committee would adequately respond to the Appellate Division opinion, DAG Chacon noted

Interim Chair Koeppe told DAG Chacon that the Board will look to the Attorney General's Office for continuing counsel on this matter.

Mayor Mahon asked if each Mayor could designate a representative to the housing committee. He would like to designate Oceanport's planner, who is with the firm Clarke, Canton and Hintz.

Interim Chair Koeppe reminded members that a standard policy of public boards is to not comment on pending litigation and he recommended this approach. DAG Chacon advised

In conclusion, there being no further business, Interim Chairman Koeppe asked for a motion to close the Executive Session and return to Public Session.

On a motion by Tom Hower, seconded by Mayor Mahon, and a unanimous vote, the Board adjourned the Executive Session and opened the Public Meeting.
