Redevelopment of Howard Commons Advances with Board Approval of PSARA

With plans to bring additional housing and retail/commercial opportunities to the area, the Fort Monmouth Economic Revitalization Authority (FMERA) Board this month authorized staff to enter into a Purchase & Sale and Redevelopment Agreement (PSARA) with American Properties at Monmouth, LLC. for the sale of Howard Commons. The 63.367-acre parcel is located on Pinebrook Road in the Fort's Charles Wood Area in Eatontown.



American Properties has proposed up to approximately 15,000 square feet of retail/commercial space on the parcel, in conjunction with 251 residential units. Two-hundred of these units will be owner-occupied single family detached residences and the remainder will be affordable housing units (for sale or for rent). In addition to the construction jobs associated with the project, American Properties has indicated plans to create a total of up to 28 permanent jobs at the property within five years.

"We share Eatontown's eagerness to get the redevelopment of Howard Commons underway," FMERA Executive Director Bruce Steadman said. "With the Board's authorization to enter into a PSARA with American Properties for the parcel this month, we are one step closer to achieving that goal."

Originally known as Eatontown Gardens, the first homes located in what is now referred to as Howard Commons were built in 1953-1954 by Wherry Housing. The complex was renamed for Congressman James J. Howard in recognition of his long-time support for Fort Monmouth and his contributions in Congress to the welfare of soldiers and the Army.
